#### THE KHASI HILLS AUTONOMOUS DISTRICT COUNCIL (CONSTITUTION OF DISTRICT COUNCIL) (AMENDMENT) RULES, 2024.

(Passed by the Khasi Hills Autonomous District Council on the 12th July, 2024)

(Received the assent of the Governor on the 2<sup>nd</sup> September, 2024)

(Published in the Meghalaya Gazette on the 4th September, 2024)

**Preamble:** Whereas it is expedient to further amend the Assam and Meghalaya Autonomous Districts (Constitution of District Council) Rules, 1951, (as amended), hereinafter referred to as the "Principal Rules" in the manner herein appearing -

It is hereby enacted in the Seventy Fifth year of Republic of India as follows: -

1. Short title, Extent and Commencement: - (i) These Rules shall be called the Khasi Hills Autonomous District Council (Constitution of District Council) (Amendment) Rules, 2024.

(ii) They shall apply to the whole of the Khasi Hills Autonomous District Council.

(iii) They shall come into force at once.

- 2. All words and expressions shall have the same meaning as defined in the Principal Rules.
- 3. Amendment of SI. No. 6 of the Appendix-V [Rule130(1)] to the Principal Rules:
  - (i) For the words "Sub-Divisional Officer, Sub-Division, Mairang", appearing in column 2, the words, "Deputy Commissioner, Eastern West Khasi Hills District, Mairang" shall be substituted.
  - (ii) For the words "Extra Assistant Commissioner, Mairang/Mairang West" appearing in column 3, the words "Additional Deputy Commissioner, Sub-divisional Officer (Sardar), Extra Assistant Commissioner, Mairang" shall be substituted.

The above Amendment Rules was passed by the Khasi Hills Autonomous District Council in Session, on the 12<sup>th</sup> July, 2024.

#### ACT

**Preamble:** Whereas it is expedient to further amend the Assam and Meghalaya Autonomous Districts (Constitution of District Council) Rules, 1951, as amended, hereinafter referred to as the "Principal Rules" in the manner herein appearing -

It is hereby enacted in the Seventy Fifth year of Republic of India as follows: -

Now, therefore, in exercise of the said power and also those conferred on it under clause (a) of Rule 30 of the Assam and Meghalaya Autonomous Districts (Constitution of District Council) Rules, 1951, as amended, and all other powers enabling it in that behalf, the Executive Committee, Khasi Hills Autonomous District Council is pleased to make the following Rules.

- 1. <u>Short title, Extent and Commencement</u>: -(i)These Rules shall be called the Khasi Hills Autonomous District Council (Constitution of District Council) (Amendment) Rules, 2024.
- (ii) They shall apply to the whole of the Khasi Hills Autonomous District Council.
- (iii) They shall come into force at once.

- 9) Delete Mawpat village under 20-Mawlai Constituency and add the same to 18-Mawkhar-Pynthorumkhrah Constituency.
- 10) Delete Laitniangtlong, Wahrisain, Laitmawsiang, Nongriwah, Sohpian, Mawkynroh, Lempluh, Marten, Wahsohlait and Dewsaw villages under 22-Nongspung-Sohiong Constituency and add the same to 21-Mawphlang-Diengiei Constituency.
