The Recruitment Committee, Khasi Hills Autonomous District Council invites applications in prescribed form from candidates who are bonafide Citizens of India belonging to the Scheduled Tribe Community of the State of Meghalaya, who can speak, read and write Khasi Language and well acquainted with the Khasi Customary laws for filling up of one (1) vacant post of Magistrate First Class, Subordinate District Council Court, Khasi Hills Autonomous District Council, Shillong in the initial pay scale of ₹62,400-1,23,100/- PM (Level-18) plus usual allowances as admissible under the rule in force.

- Essential Qualifications -
- (a) A candidate should be not less than 25 years and not more than 37 years of age as on **15.12.2025**.
 - (b) He or she should be a Law Graduate from any recognised institution/university and who has cleared the All India Bar Examination (AIBE) with a minimum of three (3) years practical experience as Advocate in a Court of Law.

Application Forms completed in all aspects with attested copies of certificates, four (4) passport size photographs and a self-addressed envelope accompanied with a Demand Draft of ₹500/- (Rupees Five hundred) only to be drawn in favour of the Executive Committee, KHADC, Shillong at Meghalaya Rural Bank, Iewduh Branch (non-refundable) should be submitted to the undersigned or **Room No.317**.
2. Candidates are required to clearly indicate the division, class and percentage of marks obtained by them as specified in the application form.
3. Last date for receiving the application is on **15.12.2025** during office hours and no application shall be entertained after the last date.
4. Applicants who fulfil the essential qualifications shall appear for written examination (in three Papers of 100 marks each).
5. Candidates who obtain a minimum of 60 marks in each Paper shall qualify for appearing in the personal interview which shall consist of 50 marks.
6. Applicants already in service should apply through proper channel and to furnish No Objection Certificate from the concerned authority.
7. Applicants shall appear for written examination as well as for personal interview at their own expenses.
