A. Document(s) to be submitted by an applicant for Non-Tribal Labour Service License:-

- i. On production of Election Photo Identity Card (EPIC) / Copy of the voter list indicating the voters name of the applicant.
Or
- ii. Certification from the In-charge of any Police Station / Police Beat House/ Police Outpost of Meghalaya State Police.
Or
- iii. Birth certificate issued by State Authorities.
Or
- iv. Permanent Account Number (PAN) card/Aadhar Card

B. Other supporting document to be submitted with one of the above:-

- i. Residential Certificate from House Owner / Certificate from the Employer, for applicants residing at the place of work.

- ii. Bank pass book
